I will sell your hametz on your behalf and in that way you will fulfill the Torah commandment. Har Zion Temple will also provide empty containers if you wish to dispose physically of your hametz foods and canned products. These will be distributed to the needy.

Let me take this opportunity, while well in advance, to wish you and yours an enjoyable and happy Passover.
